General Waiver

As a candidate for the position of full time firefighter with the Spring Mill Fire Company No.1 and / or the Barren Hill Volunteer Fire Company, I recognize and acknowledge that there are certain risks of physical injury during a physical agility test. I agree to assume the full risk of any injuries, including death, damages, or loss which the candidate may sustain as a result of participating in any and all activities connected with or associated with such an agility test.

As a candidate, I do hereby fully release and discharge the Spring Mill Fire Company No.1 and the Barren Hill Volunteer Fire Company and its appointed and elected officials, officers, agents, servants, and employees from and against any and all claims from injuries, including death, damage or loss which I may have or which may occur on account of my participation in the agility test.

As a candidate, I agree to waive and relinquish all claims I may have as a result of participating in the test against the Spring Mill Fire Company No.1 and the Barren Hill Volunteer Fire Company and their appointed and elected officials, officers, agents, servants and employees.

As a candidate, I further agree to indemnify and hold harmless and defend the Spring Mill Fire Company No.1 and the Barren Hill Volunteer Fire Company and its appointed and elected officials, officers, agents, servants and employees from any and all claims resulting from injuries, including death, and losses sustained by the participant and arising out of, connected with, or in any way associated with the agility test.

PHYSICAL AGILITY TESTING

The physical agility testing will take place on Sunday, May 19, 2019 at the Montgomery County Fire Academy, 1175 Conshohocken Road, Conshohocken, PA 19428. The candidate's application submission is their invitation to participate in the physical agility testing process. No additional communications will be made about the physical agility testing process. The physical agility testing process will begin promptly at 9:00am and will consist of various stations that demonstrate the candidate's ability to perform basic firefighting tasks. All stations must be completed successfully in order to successfully complete the physical agility testing process.

- The candidate must register for the Physical Agility test between 8:15am and 8:45am on Sunday, May 19, 2019
- All candidates must bring valid photo identification
- At the time of registration and prior to participation, all candidates must submit the signed "PHYSICAL AGILITY TEST PERSONAL INJURY WAIVER"
- Candidates are required to wear proper attire to participate in basic firefighting evolutions such as use of hand tools, climbing ladders, hauling equipment, patient removal, hose line deployment and other similar firefighting tasks. Structural Firefighting Personal Protective Equipment is NOT required. Candidates are required to wear long or short sleeve shirt, work gloves, hard sole shoes/boots and structural firefighting helmet (if your are not able to provide a structural firefighting helmet, please inform us and we will provide a structural firefighting helmet for you for the physical agility testing process.

The Spring Mill Fire Company No.1 and the Barren Hill Volunteer Fire Company are accepting applications for the position of full time firefighter for each station. (Two positions) This single application process will allow the applicant to complete one application and be considered for either or both employment opportunities. The Spring Mill Fire Company No.1 and the Barren Hill Volunteer Fire Company are equal opportunity employers.

Application & Testing Process

1. Candidates for employment shall submit the single written application at either firehouse.
2. Following the submittal of the written application accompanied by a check or money order; payable to either Spring Mill Fire Company or Barren Hill Volunteer Fire Company, all candidates will participate in the physical agility testing on **Sunday, May 19, 2019 at 9:00 am at the Montgomery County Fire Academy, 1175 Conshohocken Road, Conshohocken, PA 19428.**
 - a. *No additional notice will be sent or communicated with the applicants regarding the physical agility test following the submission of the application. The applicant's application submission is notice to attend the Physical Agility test on the date and time above. Applicants should wear long or short sleeve shirt, work gloves, hard sole shoes/boots and structural firefighting helmet (if your are not able to provide a structural firefighting helmet, please inform us and we will provide a structural firefighting helmet for you to successfully complete the physical agility test.*
3. Following the successful completion of the physical agility test, the candidate will be notified by mail of the date, time and place of an oral interview. Oral interviews will be conducted by each Fire Company individually.
4. Following the oral interview process, both fire companies may conduct background checks and medical examinations in preparation of a final candidate list for consideration of employment.

Spring Mill Fire Company No.1 and the Barren Hill Volunteer Fire Company Full Time Firefighter Job Description

Essential Job Functions

The following duties are normal for the position of full time firefighter. These duties are not to be construed as exclusive or all inclusive. Other duties not listed may be required and assigned. Examples of Essential Job Functions are as follows:

- Responds to emergency calls by driving safely to incident scenes.
- Operates equipment safely for fire and rescue operations.
- Conducts salvage operations at fire scenes as directed.
- Works in conjunction with Police and Ambulance personnel on emergency scenes.
- Follows manufacturer's instructions to complete preventative maintenance requirements to ensure equipment remains in working order.
- Follows manufacturer's instructions to complete general repairs / maintenance of fire apparatus and equipment within their ability.
- Promotes fire safety by organizing training sessions, talks and seminars.
- Conducts pre plan drills of business and properties within the response district as assigned.
- Maintains personal protective equipment to be clean and in safe working condition at all times.
- Assesses situations quickly to decide the best course of action.
- Produces accurate written reports of emergency incidents.
- Participates in educational workshops, seminars, and programs to update job skills and knowledge as assigned.

- Performs other duties and assumes other responsibilities as required or assigned.
- Perform general maintenance of the apparatus including but not limited to cleaning and repairs when it is within the scope of the employee's ability.
- Perform general housekeeping duties in the firehouse to include cleaning and repairs.
- Perform general building and grounds duties including but not limited to general repairs and routine grounds maintenance when it is within the scope of the employee's ability.

Job Standards

- Communicates effectively; reads and understands the policies of the Fire Company including but not limited to the By-Laws, Rules & Regulations, Standard Operating Guidelines, Employee Handbooks & Policies.
- React calmly and think rationally in emergency situations.
- Understand and carry out complex instructions.
- Recognize non-standard activities, missing items, people, hazards and details.
- Possess excellent eye-hand-foot coordination and physical stamina.
- Sit and perform fine manipulation frequently.
- Stand for extended periods of time, walk, run, bend, crouch, kneel, climb, crawl, lift and carry up to 150lbs, push up to one (1) ton on a flat surface, pull up to 175 lbs.
- Works well with both groups and independently.

Knowledge, Skills and Abilities

- Ability to use and maintain fire fighting equipment and to learn the theory necessary for effective firefighting and equipment operations, after a period of training.
- Ability to apply basic techniques of fighting fires.
- Ability to perform strenuous activities such as lifting heavy fire fighting equipment, climbing standard and aerial ladders, lifting and carrying people and equipment for rescue and salvage.
- Ability to work under conditions of heavy physical exertion in extreme heat and dust, in high and confined areas and smoke-filled spaces and in all kinds of weather, and to maintain physical activity for prolonged periods of time.
- Ability to administer first aid, CPR and other medical care to which the candidate is trained to do.
- Ability to think clearly and to apply knowledge under stressful conditions and to handle more than one task at a time.
- Ability to remain calm in emergency situations in all types of environments.

- Ability to establish a rapport with the community, officers of the fire company, volunteers of the fire company, members of Township Staff, the Police Department, the Ambulance Association and civilians.
- Ability to understand and carry out instructions quickly and effectively.
- Ability to record information professionally, in written form.
- Ability to function independently and without direct supervision.
- Ability to work closely with people, including functioning as a team member and to exercise tact or diplomacy and display compassion, understanding and patience.
- Ability to learn to utilize various types of electronic and / or manual recording and information systems used by the agency, office or related units.
- Ability to promote the goals and mission of the Volunteer Fire Company.

Physical Characteristics

- Sufficient clarity of speech and hearing and other communication capabilities, with or without reasonable accommodation, which permits the employee to communicate effectively, including during emergency situations which may involve a high degree of noise.
- Sufficient vision and ability conduct scene size up observations with or without reasonable accommodation which permits the employee to effectively operate at a fire or related emergency scene.
- Sufficient manual dexterity with or without reasonable accommodations, which permits the employee to operate equipment used in firefighting
- Sufficient personal mobility and physical reflexes, with or without reasonable accommodation, which permits the employee to perform all duties involved in protecting life and property
- Sufficient overall physical health, to successfully complete the pre-hire physical agility test and post hire requirements for handling rapidly moving situations where quick maneuvering in less than ideal situations involving obstacles, challenging climbing requirements and structural collapse
