BHVFC - 2021 Annual Report – 2021 Calls for Service

Members are dispatched through the Montgomery County Emergency Dispatch Center in Eagleville, Pennsylvania. Both 10 digit and 911 calls are received into the Dispatch Center and the resources are then deployed.



Members carry various electronic means of communication that alert them to the Dispatch. Some personnel use an audible / voice pager, some personnel use digital alphanumeric pagers and some use an application on their cellular telephone devices. In addition to electronic means of notification, our house siren also provides audible Community based alert so that our volunteers may respond for a dispatched emergency call for service. Regardless of how the alert is received, members stop what they are doing to respond to our Community's emergency call for service.








The chart to the left shows the number of emergency calls for service that BHVFC has responded to annually since 2008.


Type of Emergency Calls for Service

The Township is broken up into sections that are called "Boxes". Our response District contains thirteen(13) boxes. The purpose of the box system is to assure that the closest available resources are dispatched and utilized throughout our response District.



Note: Box 32-24a is identified on this chart due to the frequency of responses. A box number with a letter following it represents a target hazard which calls for special dispatch procedures.





The Barren Hill Volunteer Fire Company provides mutual aid responses to Fire Companies in many of our surrounding municipalities.


17% of responses (93 Calls for Service) in 2021 were in support of our Mutual Aid partners in the surrounding municipalities.

BHVFC - 2021 Annual Report – 2021 Weekly Training Exercises

Members meet each Monday night from 6:45pm until approximately 9:45pm to refine their skills in all aspects of Fire & Rescue services. Weekly training exercises are prepared by the Training Chief (Assistant Chief Scott Yoder) and are delivered by other Operational line officers, other subject matter experts or through outside educational institutions.



On a yearly basis, members are trained in a mix of annual qualifications and standards, hands on operations and classroom lectures.

Weekly training exercises help to not only keep our Volunteers operationally ready, but it allows our members to train with each other; recognizing the strengths within our membership and building on our weaknesses.



The small deviation to the numbers are due to Holidays or weather related cancellations that are out of the control of the Fire Company.






BHVFC - 2021 Annual Report – 2021 Weekly Training Exercises



The Barren Hill Volunteer Fire Company lost two life members in 2021:

George Russell McKee – July 25, 1929 – September 8, 2021 61 Year Life Member

Sandra Byerly – October 11, 1942 – August 15, 2021 60 Year Life Active Member



In July of 2021, the Lower Merion Fire Department suffered two (2) Line of Duty Deaths. These line of duty deaths, one in a house fire and one while operating at a traffic crash, struck close to home. These were the first two Line of Duty Deaths that many of our volunteers have experienced. While we may not have known Firefighter Sean DeMuynk or Firefighter Thomas Royds personally, they were part of our family in the fire service. May they Rest in Eternal Peace.

According to a 2019 report published by the Pennsylvania Fire and Emergency Services Institute, the number of volunteers in the Commonwealth of Pennsylvania is on a downward trend. The number of Volunteers in the Commonwealth of Pennsylvania have drastically declined from approximately 300,000 in the 1970's to a mere 38,000 in 2018. Whitemarsh Township is not immune from this downward trend.

The alternative to a Volunteer Fire Company supplemented with career staff is a Paid Fire Department possibly supplemented by Volunteers. There is a distinct difference between the two. While minimal tax money is needed to support a Volunteer Fire Company supported by career staff, a Paid Fire Department would require a significant increase in tax money to support the Paid Fire Department.
